- (a) I understand that Maxxia Fleet Limited may give a credit reporting agency certain personal information about me in order to obtain a consumer credit report about me and/or to allow the credit reporting agency to maintain a credit information file containing information about me which I hereby authorize Maxxia Fleet Limited to do. The information which may be given to an agency includes:
  - i identity particulars, being name, sex, date of birth, current known address, two immediately previous addresses, current or last known employer, and driver’s license number;
  - ii the fact that I have applied for credit and the amount;
  - iii the fact that Maxxia Fleet Limited is a current credit provider to me;
  - iv information regarding payments which are overdue more than 60 days and for which debt collection action has started;
  - v advice that payments are no longer overdue;
  - vi the opinion of Maxxia Fleet Limited that I have, in the circumstances specified, committed a “serious credit infringement” (that is, acted fraudulently or shown an intention not to comply with my credit obligations); and
  - vii information about dishonoured cheques - cheques drawn by me for \$100 or more which have been dishonoured more than once.

This information may be given during or after the provision of credit to me. I understand that I have the right to withhold personal information or request that it not be provided to third parties, but that this may limit the services Maxxia Fleet Limited is able to offer me and my ability to use the Product.

  - ii Maxxia Fleet Limited to give to and obtain from the credit providers named in any application to Maxxia Fleet Limited and any credit providers that may be named in a credit report issued by a credit reporting agency, information about my credit arrangements to:
    - assess an application by me for credit;
    - notify other credit providers of a default by me;
    - exchange information with other credit providers as to the status of my loans with Maxxia Fleet Limited where I am in default with other credit providers; and
    - assess my credit-worthiness.
